*There are no costs associated for classroom based delivery; however, candidates enrolling for Online delivery will be charged fees per unit. The fees range from \$10 to \$20 per unit.

Qualification Overview

This qualification reflects the role of early childhood educators who are responsible for designing and implementing curriculum in early childhood education and care services. In doing so they work to implement an approved learning framework within the requirements of the Education and Care Services National Regulations and the National Quality Standard.

They may have responsibility for supervision of volunteers or other staff. It covers workers who are responsible for developing and evaluating the qualification. Workers at this level have responsibility for the supervision of other staff and volunteer. Depending on the setting, workers may work under direct supervision or autonomously.

Occupational titles may include:

- Child Care Educator – Qualified
- Team Leader
- Group Leader
- Qualification Leader
- Service Director
- Special Needs Inclusion Educator

* Some jurisdictions may require CHC 30113 Certificate III in Early Childhood Education and Care and/ o/CHC40113 - Certificate IV in School Age Education and Care for these work roles

Qualification Structure

Note:

- the above hours include all teaching and learning activities such as guided learning (classes, lectures, tutorials, online or self-paced study), individual study, research, learning activities in the workplace and assessment activities. This is in accordance with AQF volume of learning.
- during this period of 120 or the 240 hours, the candidate could demonstrate competency for a number of additional units.
- the Elective Units can be changed depending on clients needs and in accordance with training package rules.



Assessment Methods

A wide variety of assessments methods will be employed to assess student competence in each unit. These include but are not limited to:

- Demonstration & Observation
- Case Studies
- Written Tests
- Role Plays
- Group Assignments
- Individual Projects/Portfolios

Note: There are workplace requirements for this qualification. Students need to be either working in the workplace or have access to a workplace for workplace exercises where needed. The practicum requirements are 240 hours.

*Please note that certain units have practical work placement hours that are required to be completed before the unit is deemed competent.

Entry Requirements

1. Applicants 18 years and above and have completed year 10 or equivalent or
2. Applicants 18 years and above with no formal qualifications who can be assessed for skills that would qualify to undertake this training.
3. Must have a current Working with Children check and a current National Police Record check or in the process of obtaining them.
4. Must complete literacy and numeracy test and the pre-training review. As a result of the pre-training review, any learners with identified barriers will be referred to the appropriate support services/office or referred externally where required. If a learner is unable to, meet the inherent requirements of the qualification, even with reasonable adjustment, Accredited Training Centre of Australia will offer counselling regarding alternative training and/or career path options.

Completion of the Qualification

Future Study Pathways

After successful completion of your Diploma, you will have many other study options available to you. These may include the Bachelor of Early Childhood (Education and Care).

Recognition of Prior Learning (RPL)

Candidates may be able to shorten the length of their chosen qualification by supplying evidence of their previous training, employment experience or other life skills that directly relate to the qualification competencies. The evidence must be valid, sufficient and authentic.

Credit Transfer (CT)

Students may be able to shorten the length of their chosen qualification by taking into account previous studies. Accredited Training Centre of Australia accepts and provides credit to learners for units of competency and/or modules (unless licensing or regulatory requirements prevent this) where these are evidenced by:

- AQF certification documentation issued by any other RTO or AQF authorised issuing organisation, or
- authenticated VET transcripts issued by the Registrar.

Credit Transfers will be granted upon the receipt of sufficient evidence to support the application and prior to the commencement of training.

Special Requirements

It is expected that all students will have access to their own personal computer and the internet. This is essential for regular research and also on-line based assessment work throughout the qualification.

Payment terms and conditions including deposits and refunds

Prepaid fees (tuition fees and materials fees) must be made to Trison Business College upon enrolment and prior to commencement of training. Trison Business College reserves the right to withdraw your enrolment if payments are not made by the due date or as per payment plan agreement.
